Attended Funeral (funeral director's charges only) £ 2,205.01

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation

Taking care of all necessary legal and administrative arrangements £ 1,130.00

Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care (we do not charge extra for out of hours) £ 230.00

Care of the deceased person before the funeral in appropriate refrigerated facilities. The deceased person will be kept at the funeral director's premises at 44 Millgate Loan, Arbroath. £ 150.00

Providing a suitable coffin - this will be made from wood effect, MDF £ 400.00

Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer). £ 0.01 *

At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle £ 295.00

UNATTENDED FUNERAL

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

Burial (funeral director's charges only) £ 1,475.00

Cremation (funeral director's charges plus the cremation fee) ² £ 1,475.00

FEES YOU MUST PAY

For an Attended or Unattended **burial** funeral, the burial fee¹ (Angus Council) £ 937.05

For pre-existing lairs an additional fee (Perpetuity Fee) may also have to be paid £ 433.55

Purchase of a new burial lair (Angus Council) Lair, Registry Certificate & Perpetuity Fee - one-off charge for the upkeep and maintenance of the lair (£871.80, £74.35 & £433.55) £ 1,379.70

For an Attended **cremation** funeral, the cremation fee²
